Dr. Wender has been really busy in the field of Public Health lately.

He is currently President Elect of the National American Cancer Society and will become President this November at their fall Board Meeting in NYC.

Also, as March is Colo-Rectal Cancer Awareness month, Dr. Wender was the spokesperson for the American Cancer Society and participated in a national media tour which reached millions of listen-

ers/viewers over TV, radio, and internet.

Wender has just testified in front of City Council's Committee on Public Health and Human Services in support of a ban of smoking in public places on Monday, March 27. Dr.

Wender would like to encourage residents of Philadelphia to contact

their City Council people to support this ban. He says, "It is NOT a done deal."

In his testimony, he states, "We know that secondhand

smoke has been classified as a Class-A carcinogen — the same classification given to toxic substances like asbestos and radon. The curious thing is that there is a great deal of legislation, both State and Federal, which protects workers from exposure to these known carcinogens. However, there is no legislated protection for workers from the equally dangerous carcinogen of secondhand smoke." In the end he opposes the point of view that it would be bad for business by explaining that many organizations are now refusing to come to cities that do not have a smoke-free policy.
