**Student Objectives**

- Explain the variability in access to care and public health resources, including the workforce in the United States and abroad;

- Describe the major environmental health hazards, their effects on individuals, their assessment and development of policies for protection of the public's health;
- Serve as a resource for information on health services, including aspects of healthcare financing and outcomes measurement;
- Delineate the legal and ethical principles that inform public health practice.

## MPH Faculty Spotlight

The Jefferson MPH Program welcomes Cathleen (AKA - "Rickie") Orr Brawer to the Program Committee and an increasing role as Advisor, Mentor, and Teacher. Rickie brings over twenty years experience in health promotion, community engagement, and teaching to the Program.

A Philadelphia native, Rickie graduated from the University of Connecticut in 1974 with a major in Education. While at UCONN she played on their first Women's Field Hockey and Tennis teams. As a certified Health and Physical Education (K-12) teacher her initial work experience was with children with learning, emotional and physical disabilities. She obtained her Masters in Public Health Degree at Temple University in 1984, with an emphasis in Community Health. She taught undergraduate and graduate courses at Temple and served as an Editorial Assistant to Dr. Karen Glanz at Temple. She later worked for Johnson and Johnson Health Management Inc. where she developed, managed and promoted on-site health promotion programs for multi-site national corporations. She also served on the Professional Advisory Board and as a consultant for Health Ink Publishing Group.

In 1990, she joined the Main Line Health System, serving as Regional Director and Director of Program Planning and Evaluation in the Community Health Department. She became the Associate Director of Thomas Jefferson University Hospital's Office to Advance Population Health in 2003. She has been instrumental in the Office's receiving over 3 million dollars in grants and contracts. She also served as the Project Coordinator for the Department of Family and Community Medicine's Center for Community Outcomes Research and Evaluation.

Rickie has been active in the local, regional and state public health community – serving on the Board and as Membership Chair for the Pennsylvania Public Health Association, on the Executive Committee of the College of Physicians of Philadelphia's Section on Public Health, as a Board member of the Women's Health and Envi-

ronment Network, Board Chair of the Southeastern Pennsylvania Area Health Education Center, Co-Chair of the Delaware Valley Hospital Association's Community Health Advisory Committee, the Network Relations Committee of the United Way of Southeastern Pennsylvania, a Board member of the Urban Tree Connection, and a long term member of the Haddington Community Health Collaborative and the Nicetown-Tioga Improvement Team.

At Jefferson, she is Course Co-Director for Social and Behavioral Foundations of Public Health, and will be Course Co-Director for the new Program Planning and Evaluation Course (PH 615). Her public health interests include community based participatory research, health literacy, the relationship of the environment to health including the built environment, and helping communities to solve problems through a grass roots approach.

Rickie loves to travel, garden and is looking forward to completing her doctorate so she has time to learn about photography and weaving. She is married to David Brawer, an Architect in Philadelphia, and has two grown children, Kristi and Josh.
