**1990 ANNUAL BUSINESS MEETING**

The meeting was called to order at 12:15 p.m. on June 11, 1990, by Lynn Ecklund. The minutes of the 1989 Business meeting were approved as written.

**Committee Reports:**

Treasurer Ellie Reiter reported that as of the end of May 1990 the Division has a positive balance among all accounts of \$12,985.03. Thanks were expressed to Mead Data Central, Information Handling Service, and AIAA for their contributions toward conference expenses. A copy of the Treasurer's Report was submitted.

Membership Committee Chair Mitzi Rinehart reports a membership of 263 members. She described her efforts in producing the 1990 Membership Directory which was made possible by the support she received from her employer, Allied-Signal Corp. A copy of the Directory was mailed to all current members, and one is sent to each new member who joins the Division. One copy has been sold for \$20.

Government Relations Chair Sandy Moltz reported on her efforts to alert Division Members when NASA, without prior notification, stopped publication of STAR. She also reported the action of the SLA Board in sending a letter to NASA protesting the process used. She noted that Tom Pinelli will be assuming responsibility during the coming year for the Government Relations Committee.

A report for the Special Projects Committee was given by Lee Jarabek, who assumed responsibility for this Committee following the untimely death of George Mendel. She reported the sale of 215 sets of the Criss-Cross Directory resulting in an income for the Division of \$11,815 (balanced by costs of \$7,755). Forty-four sets remain to be sold. Volunteers are needed to serve as Chair of this Committee and to help with its activities.

In the absence of Nominating Chair Betty Tyson, Lynn Ecklund announced the election of Sandy Moltz as Chair Elect and Sandy Spurlock as Secretary of the Division.

Old Business:

No further old business was reported.

New Business:

Lynn Ecklund began a tradition by distributing to each of her board members a "Flying Nut" pin, and thanked them for their help and efforts during the past year.

Congratulations were extended to Patricia Marshall for her election as an SLA Fellow.

A discussion was held on how best to extend the eligibility of the George Mendel Memorial Award, so that more Division members might benefit from it. This award was established during the past year in honor of George Mendel, who was killed in an automobile accident. The intent of the award is to encourage Division members in good standing to attend the Annual Conference and to make contributions in the form of papers presented, sessions facilitated, etc. Ways of publicizing the award were also discussed. Contributions to the award are still being accepted.

As incoming Chair, Phyllis Fischer asked for suggestions for a new fund-raiser, and suggested that a good candidate might be a product that all members would like to see published. She also noted that more membership information is needed for publication in Sci-Tech News.

Linda Evans from the Flight Safety Foundation asked for help from Division members in filling out a survey she has developed which gathers facts and statistics on aviation safety for a directory.

As a new feature for the Business Meeting, a paper was presented by Ralph Lewis of Lockheed. Titled "Missing Links in Valuing Information, Information Services and Information Professionals," this paper summarized research into the reasons why information and information workers are not adequately valued in the corporate environment. It generated lively discussions, and resulted in several suggestions of how Division members can share results of their own research along these lines, and communicate relevant findings to their companies and to the media. Division members were encouraged

to present similar papers at future Business Meetings, and it was noted that such a contribution would be eligible for support from the George Mandel Memorial Award.

The meeting was adjourned by Chair Phyllis Fischer.

#### NASA TO RESUME PUBLICATION OF STAR

As you may have already heard, NASA announced in late June that it will resume publication of STAR. The brief announcement stated:

NASA is pleased to announce the resumption of the printing of the Scientific and Technical Aerospace Report (STAR). We would like to thank the Scientific and

Technical Information community for its support and cooperation during this difficult period. As you know, we have been maintaining the computer database up to date in order to shorten the start-up cycle. We will be printing all the back issues and the cumulative index for 1989.

I'm sure that many of you wrote to NASA over the suspension of the publication of STAR. As an important part of the information community that depends on the dissemination of information from NASA, we need to make our voices heard. During the last few months we have seen a number of news items questioning NASA's budget. Given the budget crisis facing the US Government, NASA will be making difficult choices in the future which are bound to affect their policies on information dissemination. Though we can celebrate the small victory of STAR resuming publication, we should not stop continuing to provide NASA with meaningful input on how best to make their information resources accessible to our communities. ## THE AEROSPACE DATABASE ON CD-ROM

Dialog Information Services has announced that as of fall 1990 the Aerospace Database (file 106 on Dialog) will be available for sale as one of their OnDisc CD-ROM products. The annual subscription price will be \$3,450 for the current year plus one year backfile, or \$4,890 for the current year plus 4 years backfile. In addition there is a 20% discount on the price if you subscribe to the printed version. The database will be updated quarterly. ## FREE GOVERNMENT STANDARDS/SPECS

The Naval Publications and Forms Center (NPFC) operates as the designated government clearinghouse for unclassified U.S. Department of Defense standards, specifications, handbooks and other similar documents. The Center operates a print-on-demand system for distributing documents known as NPODS, or the Navy-Print-On-Demand System. Using this system, documents without special printing requirements such as color or photographs are printed upon request. The services of the Center are available to anyone and documents are generally provided free of charge. Industry standardization documents accepted for use by the Department of Defense are not available from the Center. Orders may be placed by mail, telephone or telegraph, and must be accompanied by a customer number. The Center utilizes CAGE (formerly FSCM) numbers as customer numbers. (CAGE=Commercial

and Government Entity, FSCM=Federal Supply Code for Manufacturers). First-time customers without a CAGE number should submit their request in writing; the return correspondence will indicate the assigned customer number for future use. Alternately, a customer number may be obtained directly from the Special Assistance Desk.

Telephone orders are placed using the Telephone Order Entry System (TOES). TOES is available from 8 a.m. to 8 p.m. (EST) Monday through Friday and can only be used by customers with a customer number and a touch tone telephone. Only current documents are available and a maximum of five titles may be ordered per call. Orders are submitted by entering the number of each document into TOES using the telephone keypad. Following is the sequence of steps performed by TOES:

1. Requests entry of customer number.
2. Confirms customer name.
3. Offers choice of options and an order, list all orders, or list a specific order. If the first option--to add an order--is chosen.
4. Requests entry of document number.
5. Confirms document number.
6. Requests entry of number of copies.
7. Confirms number of copies requested. (Steps 4 through 7 may be repeated five times)
8. Assigns total order number. Offers option to cancel total order.
9. Assigns order number.
10. Allows customer to check on status of order.
11. Tells customer "have a nice day."

The document numbers--such as MIL-HDBk-217 or MIL-S-10865--are listed in the Department of Defense Index of Specifications and Standards, or DODISS.

The DODISS is an annual publication and consists of three sections.

Part I - Alphabetized listing of documents by title

Part II - Numerical listing

Part III - Federal Supply Class (FSC) listing

The DODISS is available in either paper or microfiche (48X) and can be obtained from the Superintendent of Documents on a subscription basis or via the depository system.
