Candidates for graduation may present their inaugural theses to the Dean, any time before the close of the session. Their examination will be in the order, in point of priority, in which they present them. No thesis can, for any purpose, be withdrawn when once presented to the Dean, except the candidate shall wish to withdraw altogether as such. All students are expected to matriculate before taking any of the tickets, and are required to show their matriculation card to each professor, when they call to take his ticket.
