OHP Contributes to AHRQ Report on Patient Safety Practices

The Office of Health Policy and Clinical Outcomes has made a significant contribution to the recently published *Making Health Care Safer: A Critical Analysis of Patient Safety Practices*, a comprehensive evidence report compiled for the Agency for Healthcare Research and Quality (AHRQ) by an investigator team at the University of California San Francisco. The 640-page report, released in July, includes four chapters authored by OHP staff members Laura Pizzi, PharmD, Research Project Manager, Neil Goldfarb, Program Director for Research, and David B. Nash, MD, MBA, Associate Dean and Director.

The report identifies 79 patient safety practices in both non-medical and traditional clinical areas and evaluates and rates these practices based on their potential impact, strength of supporting evidence, and implementation. The purpose of the report is to assist health care organizations in taking actions to improve the safety of the care they provide and to inform research funders about potential investments for their support. In addition, the National Forum for Health Care Quality Measurement and Reporting (NQF) will use the results to identify a set of proven safety practices for consumers to refer to when choosing their health care providers. This publication represents the first comprehensive effort to examine patient safety using evidence-based medicine.
