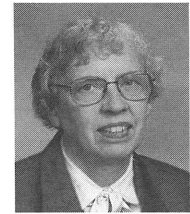

Since the end of November I have been pondering what to write. I have been organization president/chair before and I always hated the "message" duty. Can you believe that? I was a technical writer for most of my career but librarian only two years and pseudo librarian where half my work as a technical writer was really library work for over nine years. She and her husband were able to get there on the tractor a few days later (before Christmas). The dogs were out of food in their dishes but had water yet. The snow in my driveway of 0.2 miles was belly-deep to the tractor. It had taken them four

hours to clean out their driveway and get to the road. It is about as long as mine.

I had been making 3 trips a week hauling what would fit. My kitties are moved, three living room chairs, two dressers, 145 patio blocks I had used to pave the dog pen. They will make walks here, boxes and boxes of papers, books, etc. I want to sell my piano because Mom has one like it. I haven't advertised anything yet because a cousin is interested in the piano yet. Also, I want to sell my dining table and chairs, the hide-a-bed sofa, and maybe my antique (treadle) sewing machine. It does work. Mom also has a older one (circa 1887) that works. I gave my dog kennel to my neighbor for rescued pets. She gets my extra crates and carriers too. If I ever show dogs again, it will be most likely after my mother passes.
